The purpose of the letter is to request a space on the next Park & Rec monthly meeting agenda.

Julie and I would like to meet with the committee and discuss our concerns over the placement of boat lifts at the Village of Pewaukee's bait shop on Pewaukee Lake. We have just purchased a condominium at the above address this past summer and have come to find our view of the lake being blocked by the lifts which are being stored along the shoreline by the owner. The placement of these lifts significantly hampers our enjoyment and use of our property. We are obviously concerned that we will have to look at these unsightly obstructions 7 to 8 months of every year.

We would also like to request copies of all ordinances and conditional use permits or variances that apply to the bait shop and the Village's placement of lifts allowed per foot of frontage. We would also like to discuss how those permits align with State law and DNR codes.
