Continued discussion and possible action regarding request of neighbors to Laimon Park to move lifts off site during winter months.

BACKGROUND:

As a reminder, there were two neighbors who requested to have the lifts moved off site during the winter months as they feel the lifts interrupt their view of the lake from their condo. At the February meeting the Joint Board asked that I research other lift storage venues and possible storage re-configurations on site.

I don't have any new information to share at this point. I have not been successful in finding another alternative lift storage/removal operation so we only have a quote from the one. Secondly, my staff and I spent time looking at the property trying to figure out an alternative configuration for the lifts there and did not come up with anything I feel comfortable recommending. The way the lifts are removed from the water now is with a large barge and crane company from the water and they are placed directly on shore without my staff having to move them.

Alternative configurations for storing the lifts on site that would solve the neighbor's concern would only be to move them to the back side of the baitshop where we have public parking stalls. I believe we would have the same concern from residents who pass by the park that not only have we given up public parking but now they have to see them from the street side. Plus it would require my staff to move them which is not a simple task and increases liability on behalf of the Village when moving property that does not belong to us.

At this time I cannot recommend an alternative from what we currently do because of the financial responsibility we have to the Village, the safety of my staff in moving those lifts as well as the liability we would incur by moving them.

2018 Summer Offerings

<u>Quarterly Recreation Programs Report</u> <u>Winter/Spring 2018</u>

This Recreational Programs report covers programs offered in our Winter/Spring 2018 Program Guide.

Summary:

Programming is generally slowest during the Winter and early Spring months. This year has followed suit and numbers have been on the lower side for most of our programs – primarily in youth programs.

Preschool

We offered some evening classes for Preschoolers per parents' requests. We offered a music class, an art class, and dance classes. There was very little interest in any of them. The art class we ran with just four children and all the music classes were cancelled. Dance classes were cancelled also, due to instructor issues and low enrollment. Our daytime preschool classes were well attended.

Youth

Our youth classes struggled due to some instructor issues. However, our youth art classes are gaining a lot of momentum and the upcoming class starting March 22 is full with a waitlist.

Summer Day Camp and SPARK Pre-registration for returning campers started March 1st. I expect to have all program locations full for summer.

Adults

Adult programs have been successful. The enrichment classes have seen a good amount of interest and our yoga classes have gone over well. We added a Thursday evening yoga class at Horizon school. Unfortunately we have already had 2 dates that we had to move to a different facility because of space conflicts that were shared with us after we booked the space. School activities take priority. An additional issue is that we were to have a storage space for mats and blocks, and then we did not have that available to us. Our instructor now brings equipment with her weekly. I think we will still continue to use school space if available but will keep account of conflicts.

Seniors

Senior classes and programs are still thriving, even with the colder weather and seasonal travelers.

Trips/Events

The majority of these do not happen until later in the spring. Numbers are looking decent for everything except the trip we are offering with Hartland Parks & Rec (American Girl Trip).

Items of interest:

Summer Facility Use: South Park will be receiving a new furnace that includes air conditioning so that is where we will be moving all of our fitness classes (and a few other classes) in the summer.

Staffing: Our summer job postings are online and we are starting to see some interest. I will be hiring 20 new seasonal staff and am interviewing for those positions now. I have over 30 returning.

Program Feedback: I have created online program surveys for all of my program areas and they are on our webpage. Each session, participants will be sent a link to the survey to gather feedback about their experience and to give the opportunity to share input and ideas for future programs.

Funding: I was able to secure a large donation from the Pewaukee Junior Guild to purchase an online child check-in and monitoring system for our SPARK program. The unit cost just under \$1000 and the Guild funded it in full.

Pewaukee Area Art Council has set aside \$300 in funds for Summer Art Programming.

I am working with the Marketing contact at The Corners of Brookfield shopping center on a partnership that will hopefully result in some sponsorship and funding – specifically for program supplies.

Pewaukee Parks and Recreation Fundraising Campaign – Sports Complex and Beyond Initial Theme Ideas – 03.12.18

PEWAUKEE PARKS. BUILD. COMMUNITY.

This theme speaks both directly to capital and facility development, but also what the Parks offer Pewaukee – they "build community". This theme would fit with both short- and long-term fundraising goals. It's a less-direct fundraising call-to-action, but can be paired with copy and messaging that speak to the campaign goals.

Knock It Out of the Park: Give to Pewaukee Parks

This theme more directly ties to the Sports Complex effort, but does offer a play on words that could be used for general and ongoing fundraising for all Parks. It is a strong call-to-action to really urge people to take their investment in the Parks above and beyond.

3. Fund Your Happy Place: Give to Pewaukee Parks

This theme is a play on the phrase "Find your happy place," and speaks to the joy that people of all ages experience have when they visit a park in their Pewaukee community. This is also a direct call-to-action for the fundraising effort, and ties ownership of the parks to the audience through the use of the word "your".

Park Pride: Give to Pewaukee Parks

This is an aspirational call-to-action aimed at rallying the community's pride around their parks, and to donate to keep Pewaukee Parks something the community can continue to be proud of, from the new Sports Complex to all the parks.

5. This is Your Backyard: Give to Pewaukee Parks

This theme uses the idea that the Pewaukee Parks are such an integral part of the community and neighborhoods, to the extent that they are almost an extension of someone's own property, or backyard. It also offers a sense of community ownership and investment through the use of the word "your".
