- 1. Call to Order and Pledge of Allegiance
 - Mr. Blackwood called the meeting to order at 4:30 p.m.
- 2. Public Comment None.
- 3. Discussion and Possible Action to Approve the Bike & Pedestrian Planning Committee Meeting Minutes Dated March 28, 2018

A motion was made and seconded (R. Grosch, R. Ford) to approve the March 28, 2018 minutes. Motion Passed: 4-For, 0-Against.

4. Discussion Regarding the Creation of a Greenway System Within the City of Pewaukee [Blackwood]

Mr. Blackwood stated they wanted to set up a map of the routes between parks and other natural areas. It is a combination of existing trails or subdivision roads. For now it would be for proposed future trails because we do not have the infrastructure on the County highways.

Mr. Blackwood then showed some of the sketches he put together and noted the green areas are parks within the City and the red lines are proposed County paths.

The Committee then discussed the routes of the system and the various connections that could be made to other trails and roadways. Discussion also took place regarding which roadways to stay off of, as well as issues pertaining to the railroads.

Discussion took place regarding a possible connection to a future County park on Ryan Street in the far northwest corner of Pewaukee. It has been dedicated as a future park and they wanted to find a possible connection to Lindsay Road in that area.

Mr. Grosch felt there wasn't anything on Duplainville Road and he suggested a possible connection on Green Road. There are currently no parks in the Duplainville Road area.

Mr. Blackwood stated he would download the map into google maps and send it out to the Committee members.

5. Update Related to the Safety Brochure [Ford]

Mr. Ford stated they got the go-ahead for the brochure so they are set to use it. It is currently on the City's website on the Committee's page. He stated he could get the members the files.

6. Update Action Taken by Common Council on April 16, 2018 Regarding the Project List for Updating the Bicycle and Pedestrian Plan and the Impact Fee Study

Mr. Blackwood stated City Engineer Jeff Weigel took the Committee's recommendations, as well as the recommendations from the Public Works Committee and the Park Board from a couple years ago, and presented them to the Council. He requested approval to update the plan and the impact fee study. The Council agreed to have Mr. Weigel update the plan so that the projects would be eligible to use impact fee funds. The current projects on the plan before this update were too large to use funds without having matching funds or other City funds, so nothing has ever happened with those.

It was noted that there is about \$140,000 in funds right now and they have a year and a half to use the remainder of the funds. The fund has been averaging about \$25,000 a year.

Now that the list has been approved, it is now just a matter of getting the plan and the impact fee study updated, and the Council will then have to approve the updates.

7. Discussion to Select the Next Meeting Date and List Possible Future Topics

Mr. Vitale noted the bike rodeo was set for May 17th from 5:00 p.m. to 7:00 p.m.

The next meeting was scheduled for Wednesday, May 23rd at 4:30 p.m.

Mr. Blackwood mentioned that Ms. Leonhardt is moving out of the community so the Committee will need an additional member or two.


