1. Call to Order and Pledge of Allegiance.

Mr. Blackwood called the meeting to order at 4:30pm.

- 3. Discussion and Possible Action Regarding the Meeting Minutes Dated April 25, 2018

<u>A motion was made and seconded (R. Grosch, R. Ford) to approve the April 25, 2018 minutes.</u> Motion Passed: 3-For, 0-Against.

4. Discussion and Possible Action Regarding the Creation of a Greenway System within the City of Pewaukee [Blackwood]

Discussion took place regarding the City and Village of Pewaukee and City of Waukesha boarders.

Mr. Grosch felt that eventually there could be a future path off the side on the WCTC property. The question would be where the connection would be because they do not want to encourage people to use Highway SS.

Mr. Blackwood felt trying to get path along Highway G is a long time coming. It would be a matter of funding, as funding would probably be a million plus. There would eventually be funds available to use from the impact fee study.

Discussion then took place regarding a connection from the future county park on Ryan Road down to Lindsay Road. A connection could be shown on the map for future planning purposes and they would not have to find exact routes.

The Committee then discussed the responsibility of the maintenance of the paths as relates to connections thru subdivisions.

Mr. Blackwood referred to Lindsay Road and noted that there is no good way to get from the vast majority of the City to Balmer Park or the Sports Complex.

A connection to Wagner Park was discussed either thru Five Fields or down Green Road. It was noted that the shoulder on Green Road is now a great shoulder for bikes and walking. The easiest solution would be to connect either on a cul-de-sac that abuts the park or on the street on the north side of the park by the tennis courts. If that was the case they would need to discuss funds with the Park Department.

Mr. Grosch then referred to a crossing near the Fire Department. He felt there was not much residential in that area. Mr. Blackwood noted there is an access on Highway 164 and an access on Ridgeview but there are no buttons to press at the traffic signal. The Committee had previously discussed working with the state to request a button.

Discussion then took place regarding updating the plan and adding the projects to the impact fee study, as well as the funds available to use. Mr. Blackwood felt if we could at least get the pedestrian crossing on Highway 164 and at least the two crossings on Highway SS, that would be a good start. They would have to evaluate whether or not the one on Highway G would have enough site distance to be safe.

5. Update on the Pewaukee School District Bike Rodeo [Vitale]

Mr. Blackwood stated the turnout was great and there were about 150 to 160 participants. It went well for a first time event. He felt it was good to have the stations staggered with time slots.

6. Discussion to Select the Meeting Date and List Possible Future Items

Mr. Grosch mentioned that they never got a meeting together with the other communities for the lake route. Mr. Blackwood stated he needs to meet with Jeff Weigel about that to get a representative from each community. Discussion took place regarding the signage for that route.

Another topic for a future meeting could be discussion regarding use of the 2019 impact fee money.

Mr. Ford stated they should discuss a strategy to find a new member. The Committee is down two members.

The next meeting was scheduled for Wednesday, July 25th at 4:30pm


